The digital currency market has swiftly evolved into a revolutionary power in the worldwide economic landscape, offering significant potential for digital enterprise development

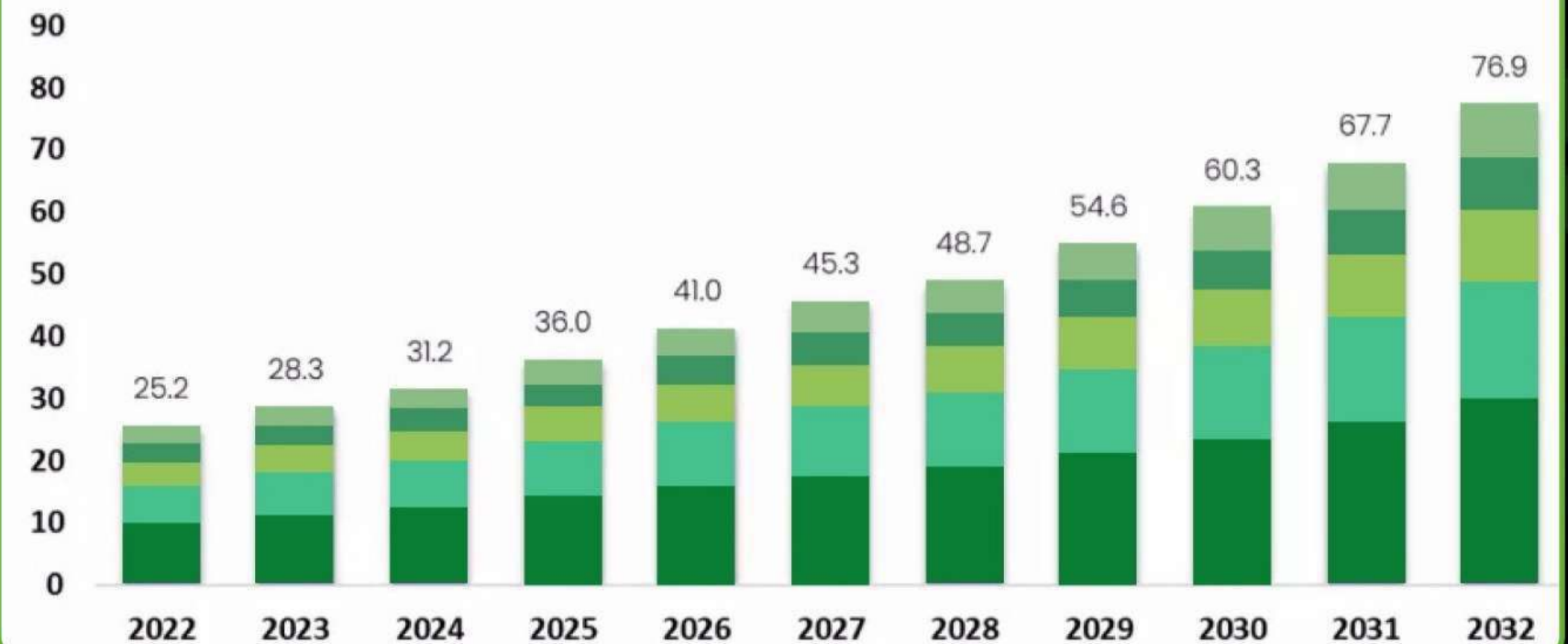
